# DOT Approved 12-Hour OWI Course

## OWI Program:

- This 12-Hour Class is available to anyone who has received an OWI in Iowa.
- An OWI is charged when a person is under the influence of any substance including alcohol or drugs which impairs judgment.

## Research-based Course

The 12-Hour OWI Program is based on research. The instructors do not moralize, judge or dictate. The course provides new information and support in order to assist people in exploring new beliefs and changing behaviors.

## Fees

All OWI classes in the State of Iowa are required to charge the same amount for the 12-Hour OWI Course. The fee is \$180, which includes the student manual.

## Instructors

All of our instructors have been certified by the Prevention Research Institute.

In order to meet the Iowa Department of Transportation requirements, participants must be on time and must complete the full 12 hours of class. Completion of course will be sent electronically to the Iowa Department of Transportation (DOT).
